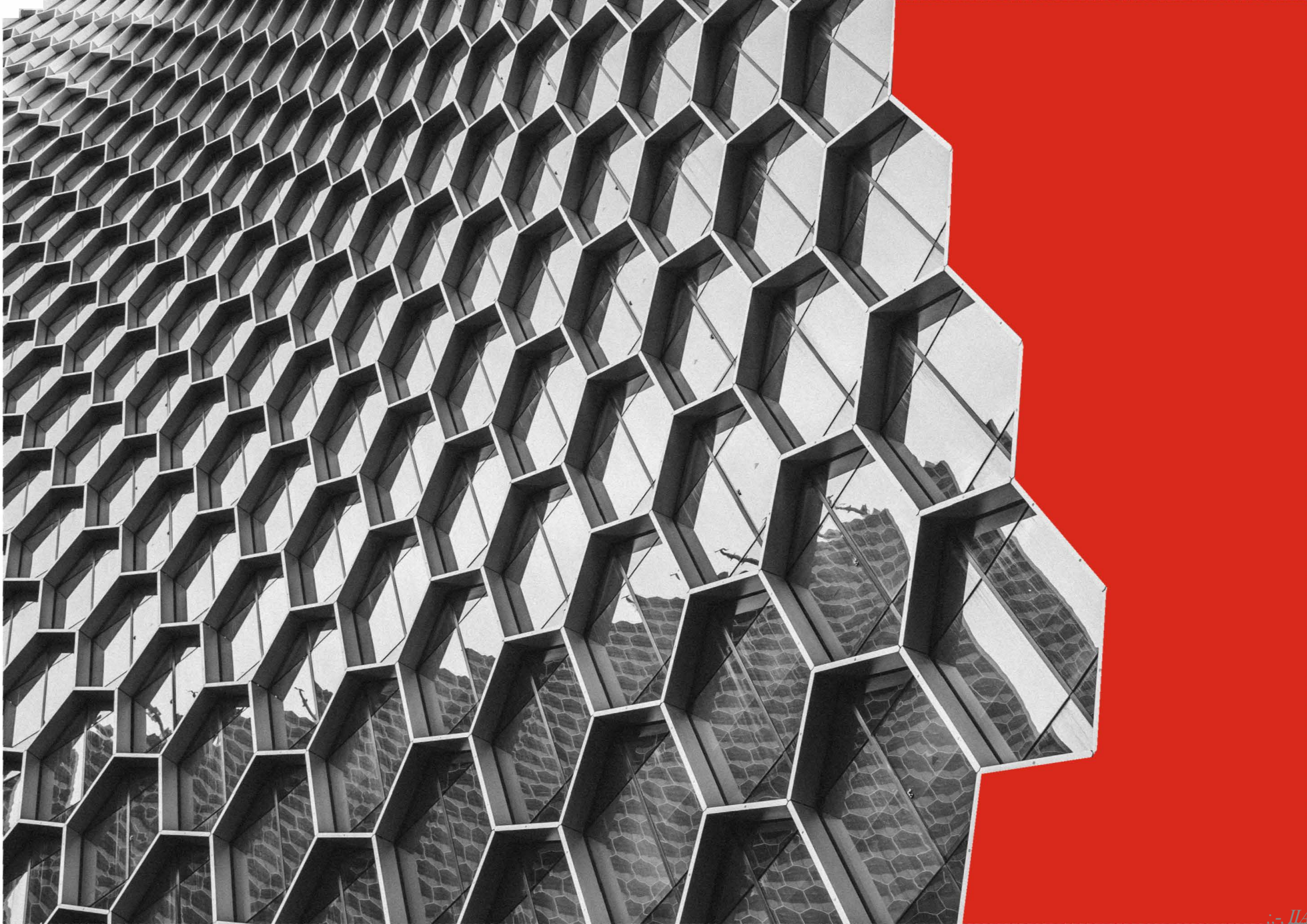

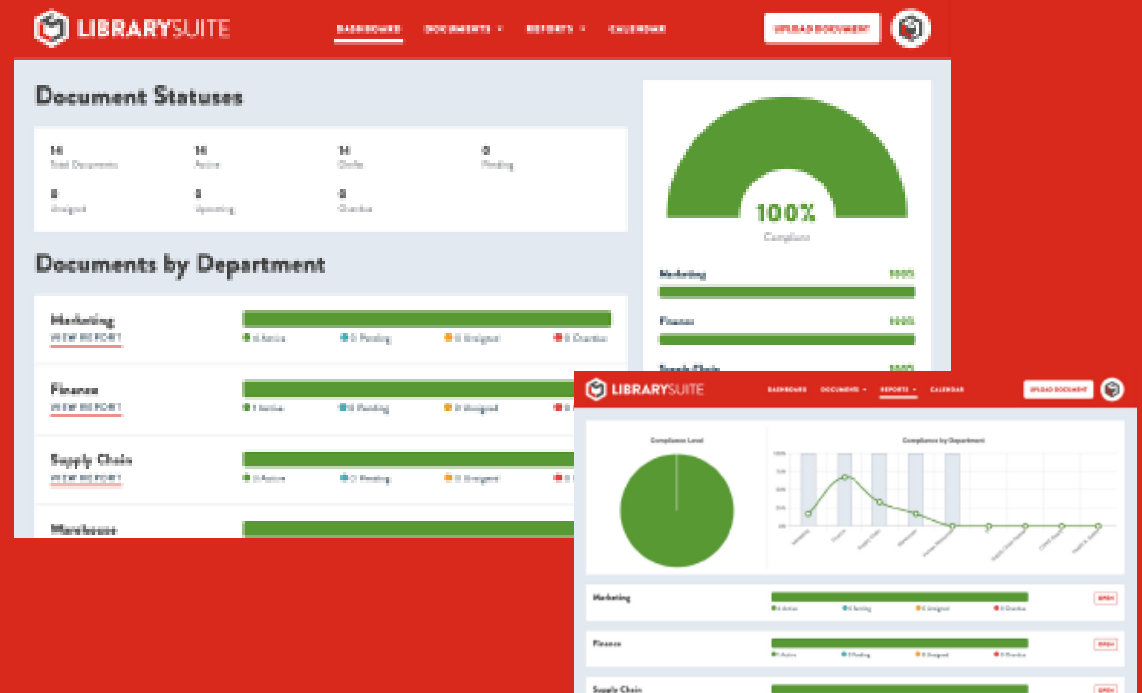
LIBRARY SUITE's Single-Window Doc Management Platform

Library Suite stores all processes and e-sign documents on our secure cloud server. This means when it comes to auditing you have access to everything in a single view. This includes full 'archiving' and 'search facility'. There is also an in-built 'anti-duplication system' that prevents files being duplicated, ensuring your files are protected and only current files are shown at all times. You can allocate tasks to teams and individuals within your organisation and see when they have been completed or updates approved. There is also a 'diary prompting' feature which auto-manages all your document 'reviewing and planning' processes.

Being cloud based with access permission protocols, Library Suite allows for safe and secure 'internal & external' control of updates, so you are not limited by a physical location

Library Suite keeps everything safely protected, so you don't need to worry about viruses, virtual attacks and corrupted data.

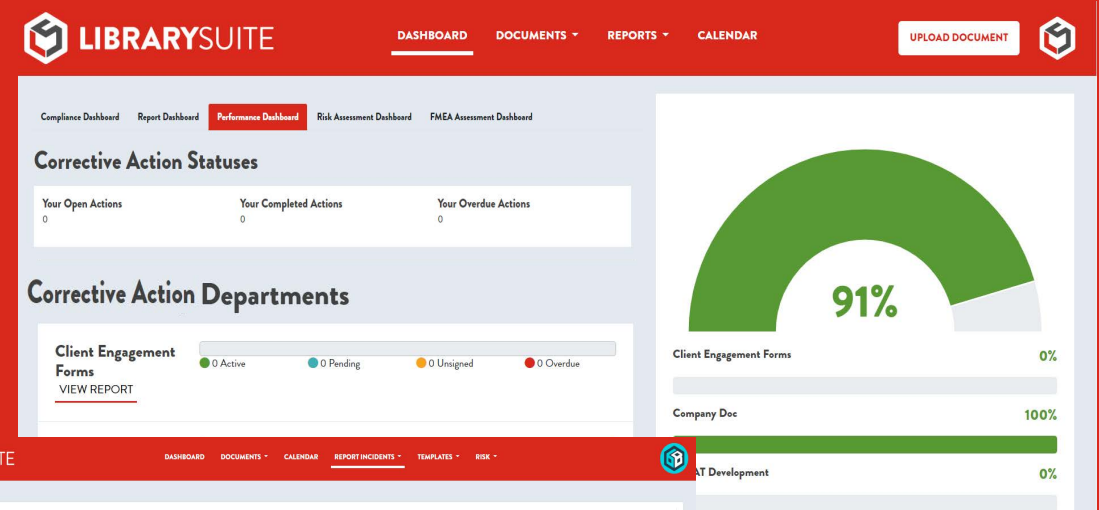
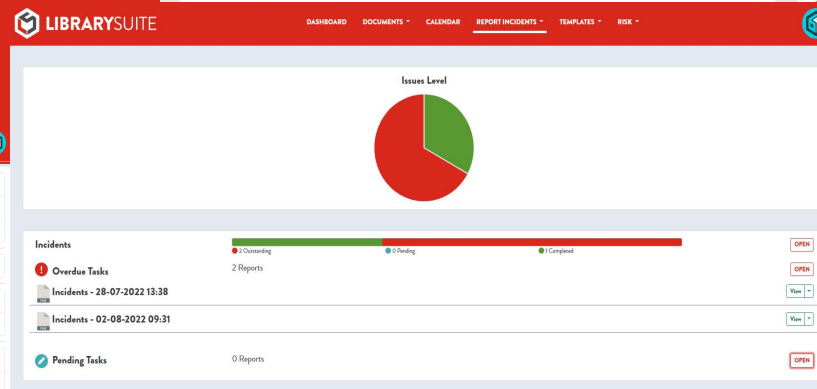
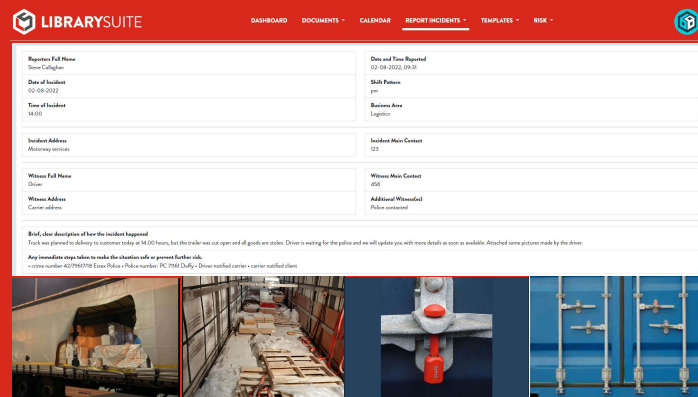


LIBRARY SUITE's Single-Window Report Platform

Library Suite facilitates 'Live Reporting' so that Incidents and Risks occurring at any time within the supply chain, whether inside a warehouse, during transit or collection at port, can all be reported at a touch of a button. This works well as part of the CTPAT Editions Cargo Flow Management meeting CTPAT requirements.

This feature by Library Suite can be used on any mobile device, to create the risk report form, along with photographic evidence taken by the device. All can be quickly uploaded and sent to nominated persons for 'live investigation and action'

These can also be reviewed, updated with the ability to create corrective actions and re-assignments. These can be also be measured for progress and completion, giving full control of risk management within global supply chains.

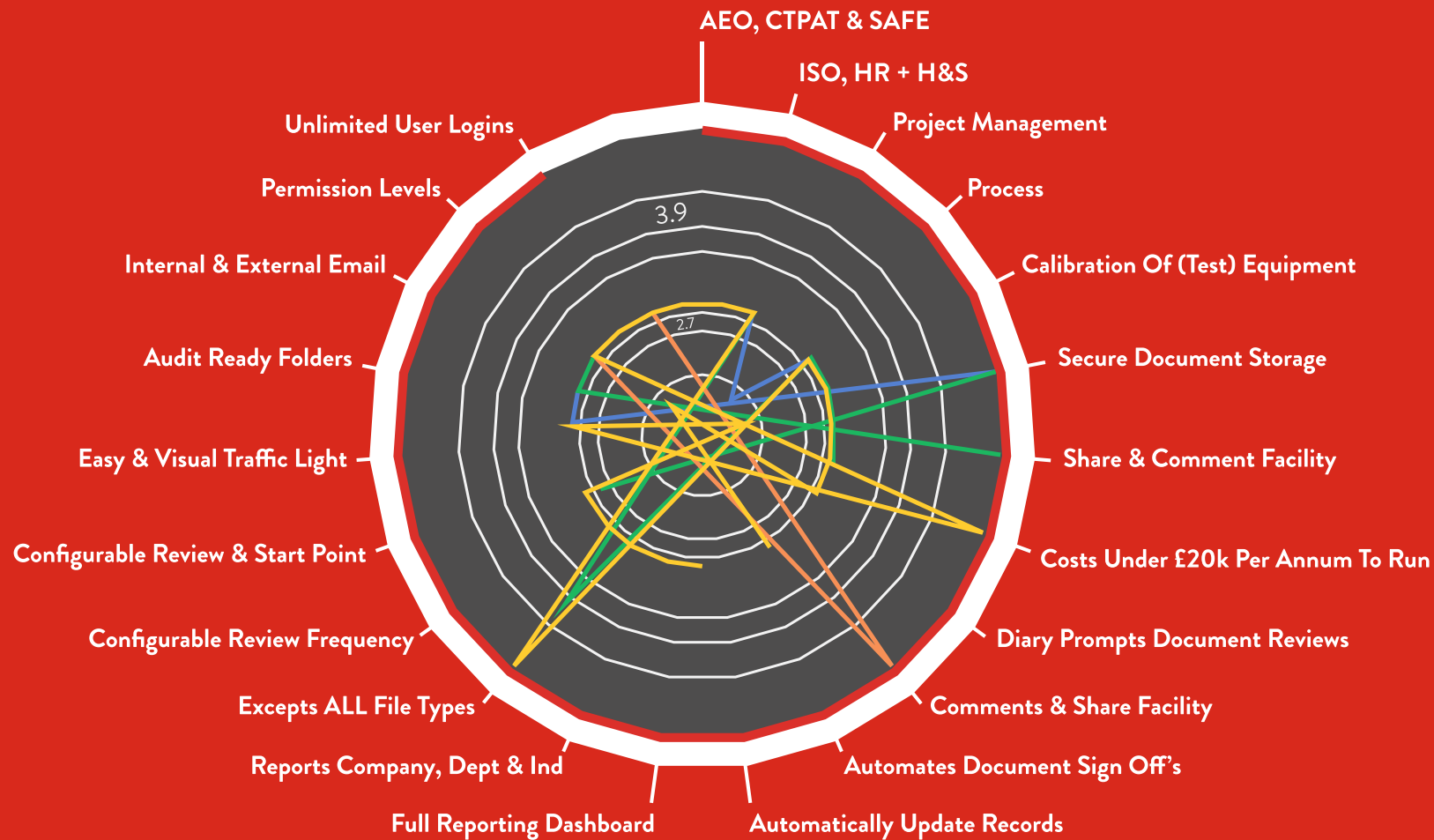

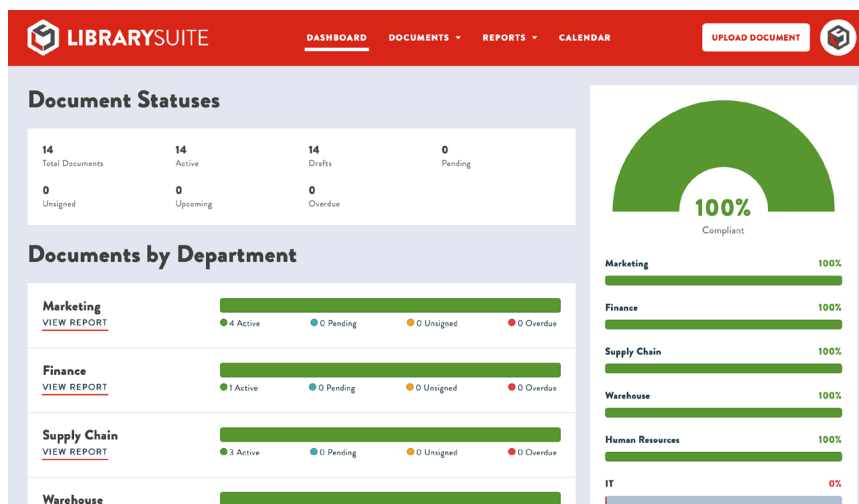
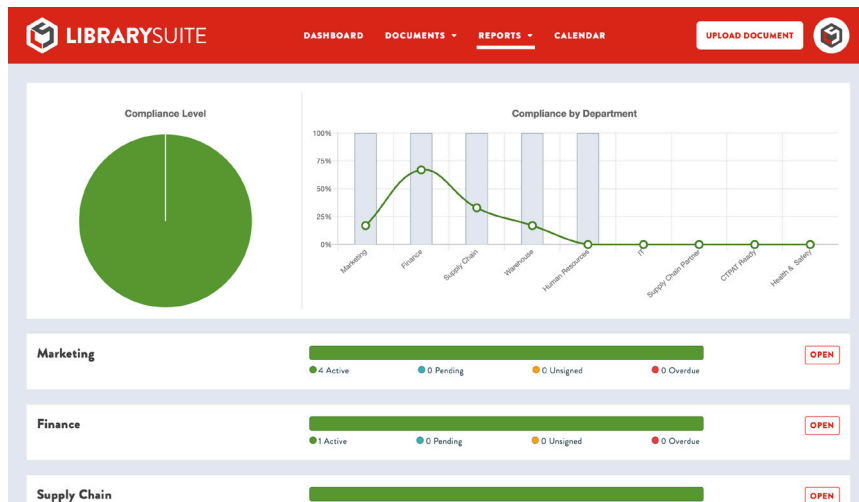
